

Mandatory requirements for professional experience

All pre-service teachers must meet mandatory requirements prior to enrolling in and commencing any Professional Experience unit. The requirements vary across States and Territories. It is the pre-service teacher's responsibility to ensure they have met the appropriate requirements and are eligible to work with children. In order to undertake a Professional Experience Placement in a centre or school setting, you must meet ALL criteria for the State/Territory that you will undertake your Professional Experience in. All pre-service teachers who have lived in another country for 12 months or more must provide a police check from that country for that period.

You must also have supplied ACU with evidence of the following mandatory documentation. You must upload a copy of your mandatory documentation through [InPlace](#) and have it verified by the professional experience staff. Any pre-service teacher who does not meet the mandatory requirements will not be allocated a placement. ALL ACU pre-service teachers are also required to complete and sign the Fitness to Teach and Commitment to Professional Conduct.

In some state jurisdictions, the relevant approval documentation must be carried whenever the pre-service teacher is on centre/school grounds or undertaking responsibilities associated with the placement (e.g. Excursion, school camps etc.)

All States and Territories	You must complete the ACU Preparation for Professional Experience Modules the ACU Child-Safe Organisations Module .
Australian Capital Territory	<p>You must complete the Working With Vulnerable People Registration and provide ACU with the details.</p> <p>Pre-service teachers completing placement in an ACT school must be approved on the Pre-Service Teacher Register. Before you apply you will need scanned copies of your WwVP card, 100 points of ID and evidence of enrolment in a current ACU Course. You can use an extract (screenshot) of the top section of the 'Current Enrolment' PDF that can be generated from student portal.</p> <p>You will then need to apply to the Pre-Service Teacher Register. Students are responsible for ensuring their details remain up to date in the register.</p>

Location	Details
<p>New South Wales</p>	<p>You must complete a NSW Working with Children Check and provide ACU with a copy of the Clearance Number and expiry date.</p> <p>The NSW Department of Education outlines mandatory pre-requisites for ALL Pre-service teachers, including completion of the Tertiary Practicum Student Application Form and the Child Protection Awareness Training. You will need to provide ACU with the automated certificate of the training. FAQs related to the training are available here.</p> <p>Pre-service teachers must provide evidence that they have been trained in managing Anaphylaxis. You must provide a copy of your certificate to the university by uploading this to InPlace. This certificate will be validated at the school/centre once the pre-service teacher demonstrates correct use of a trainer epi-pen. Certificates are valid for 2 years.</p> <p>Pre-service teachers completing placements in Schools for Specific Purposes(SSPs) – specifically, but not limited to, Bachelor of Education (Primary and Special Education) and Bachelor of Education (Secondary and Special Education) students - need to ensure they meet the Covid-19 vaccinations requirements for SSPs and upload proof of vaccinations to InPlace.</p>
<p>Northern Territory</p>	<p>You must complete a NT Working with Children’s Clearance and provide the university with the details.</p>
<p>Queensland</p>	<p>You must complete the Blue Card application and provide ACU with the Card number and expiry details. In date copies of your card must be uploaded as an attachment to InPlace. Pre-service teachers cannot commence placement without a physical copy of their card.</p>
<p>South Australia</p>	<p>Pre-service teachers must complete a SA Working with Children Check and upload all details and expiry information to InPlace.</p> <p>Where a Pre-Service Teacher already holds a valid DCSI history screening clearance this will be recognised as WWCC under the law, until they expire. Pre-Service Teachers must provide ACU with the details.</p> <p>All pre-service teachers are required to complete a full day Responding to Risks of Harm, Abuse & Neglect - Education and Care (RRHAN- EC) training. Please provide ACU with you Certificate of Completion.</p>
<p>Tasmania</p>	<p>You must hold a current Registration to Work with Vulnerable People and provide ACU with the details.</p>
<p>Victoria</p>	<p>The Department of Education and Early Childhood (Victoria) required all pre-service teachers to hold a current Working with Children Check. You must upload a copy of your WWCC card, clearly showing photo, card number and expiry date.</p>

Western Australia You must provide evidence of a current, valid [Working With Children's Check](#) and provide the details to ACU.
If you are over 18 you will need to supply ACU with evidence of a valid National Police History Check from the [Department of Education Western Australia](#). The National Police History Checked as issued by the Department of Education Western Australia is not the same as a State or Federal police clearance.

Location	Details
Outside Australia	Students must provide evidence to the Professional Experience Office, that they have applied/met the legislation requirements of the relevant country, in order for their placement to be confirmed.
